Local Law To Amend the "Code Enforcement Officer" Chapter of the Code of the Village of Penn Yan.

Notice is hereby given that at a meeting of the Board of Trustees of the Village of Penn Yan, County of Yates, State of New York, held at the Village Hall, 111 Elm Street, Penn Yan, New York, on the 18th day of July, 2023, at 6:05 p.m. the above proposed Local Law was duly adopted.

Local Law 11 of the year 2023

A Local Law providing that the Board of Trustees amend Article I "Code Enforcement Officer", of Chapter 19 "Officers and Employees", of the Village Code, to provide that the Code Enforcement Officer, Deputy Code Enforcement Officer(s) and any acting Code Enforcement Officer(s) be answerable to, as well as under the control and supervision of the Village Mayor and/or Deputy Village Mayor.

Be it enacted by the Village of Penn Yan as follows:

Section 1. Legislative Intent and Findings

It is determined for efficiency purposes and in consideration of the volume of work and responsibilities prescribed to the position of Director of the DPW and Deputy Director of the DPW that the Code Enforcement Officer, Deputy Code Enforcement Officer and any acting Code Enforcement Officer be directly answerable to, as well as under the control and supervision of the Village Mayor and/or the Deputy Village Mayor.

Section 2. Short Title.

This Local Law shall hereafter be known as: "The Village of Penn Yan Code Enforcement Officer Amendment of the Village Code of 2023".

Section 3. Legislative Authority

This Local Law is adopted pursuant to the provisions of the Municipal Home Rule Law of the State of New York.

Section 4. Provisions.

- § 19.3 of Article I "Code Enforcement Officer", of Chapter 19, "Officers and Employees" of the Code of the Village of Penn Yan is amended to provide as follows:
- §19.3 Code Enforcement Officer, Deputy Code Enforcement Officer(s) and Acting Code Enforcement Officer(s) under the control and supervision of the Village Mayor and/or Deputy

Village Mayor.

Within the structure of the Government of the Village of Penn Yan, the Code Enforcement Officer, together with any Deputy Code Enforcement Officer(s) and/or Acting Code Enforcement Officer (s), as public officers, all of whom require certification by the State of New York to hold these offices, shall be answerable to, as well as under the control and supervision of the Village Mayor and/or Deputy Village Mayor of the Village of Penn Yan.

Section 5: Severability Clause.

In the event that any section, paragraph, subdivision or provision of this local law shall be held invalid, such invalidity shall apply only to the section, paragraph, subdivision or provision adjudged invalid, and the rest of this Local Law shall remain valid and effective.

Section 6. Effective Date

This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York, subsequent to having been duly adopted by the Board of Trustees of the Village of Penn Yan.
