Pursuant to 16 NYCRR 720-8.1, the Village of Penn Yan's Electric Department hereby provides notice that on December 21, 2023, it filed a rate request with the New York State Public Service Commission with a proposed effective date of June 1, 2024, subsequently postponed to a proposed effective date of July 1, 2024. In the filed session of June 20, 2024, the State of New York Public Service Commission authorized the Village of Penn Yan Municipal Electric an increase in annual revenue of \$925,564, or 29.27% to total revenues, to become effective July 1, 2024. The new rates will be published and inserted in customers July bills, which will reflect the new rates. The rate increase allowed of 29.27% is uniform to all base rates elements and energy charges per kWh for all service classes. For a typical residential user, your total bill with PPAC included is expected to increase 20.08% depending upon electrical consumption.
